## **NOTIFICATION**

Whereas certain services in Panchayat Raj and Rural Development Department have been declared as essential services under the Andhra Pradesh Essential Services Maintenance Act, 1971 by notification issued in the references 1<sup>st</sup> and 2<sup>nd</sup> read above and published in the Extra-ordinary issue of the Andhra Pradesh Gazette No.248 Dt.5.7.1983 and in an Extra-ordinary issue of the Andhra Pradesh Gazette Dt.8.8.2011.

- 2. And whereas, the Government are satisfied that in public interest that it is necessary to prohibit strikes in the following essential services;
  - 1 Andhra Pradesh Panchayat Raj service All cadres
  - 2 Andhra Pradesh Panchayat Raj Sub- ordinate services -All cadres
  - 3. Andhra Pradesh Rural water supply engineering service All cadres
  - 4.Andhra Pradesh Panchayat Raj Engineering sub- ordinate service Restricted to staff dealing with services pertaining to rural water supply
- 3. Now, therefore, in exercise of the powers conferred by sub-section (i) of the section 3 of the Andhra Pradesh Essential Services Maintenance Act, 1971 (Andhra Pradesh Act No.20 of 1971), the Government of Andhra Pradesh hereby prohibits strikes in the said essential services for a period of one year from the date of issue of this order.
